Notice is hereby given that the Retirement Committee of the Board of Directors of the Brazos River Authority will meet at 9:00 a.m. on March 23, 2021 (A quorum of the Board of Directors of the Brazos River Authority may be present; however, this is a committee meeting, not a Board meeting, and only committee members are allowed to take action on matters discussed.)
