

- 2005-2007 Belton-Stillhouse transfer system concept approved and new System ulletWater Availability Agreements executed
- 2009-2015 Bell Co. WCID No. 1 contract amendment and evaluation of pipeline project partnership with Brazos River Authority
- 2015-2018 Additional project due diligence
 - Reassessment of stand alone project vs. use of Bell Co. WCID No. 1 infrastructure
 - Monitoring and evaluation of existing and projected water use

- Project needed to meet water demands by about 2025
- Total cost currently estimated at \$40 \$50 million
- Request for Proposals published in late 2018 to procure professional services needed to move project forward
 - Received five proposals
 - Interviewed three project teams
 - Recommending a contract with team led by Walker Partners
 - Recommendation vetted through & supported by BRA Risk Management Committee
- Next Steps
 - Execute contract with Walker Partners for Phase I (project alternatives evaluation) & preliminary engineering design)
 - Negotiated contract amount of \$2,665,867


