
Property Information

- Location
- Grantor, Grantee, Acquisition Date, Sale Date
- Applicable Lease Information
- Abstract, abstract number, county, ownership type (fee, easement, lease, release, etc.)
- property use (BRA operations, recreation, conservation, inundation area, no build area, leased, unleased etc.), size, and encumbrances (zoning, groundwater conservation district, ETJ of a City, utility easements reservations etc.)

- Watershed and associated aguifers
- Mineral right information
- Open record request tracking and property inquiries.
- Species of concern
- Cultural resources
- Identification of properties adjacent to WOTUS and/or Section 10 waters
- Identification of properties with or adjacent to special habitat features or habitat for species of concern (nursery habitat for fisheries support), and water quality buffers.

Resolution

"WHEREAS the Brazos River Authority is pursuing a Property Master Plan at the direction of the Property Management Committee at its September 9, 2019 meeting;

WHEREAS the Property Management Committee took action at its October 1, 2020 meeting for the Brazos River Authority to enter into scope and fee negotiations with Halff Associates to develop a Property Master Plan;

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Brazos River Authority hereby authorizes the General Manager/CEO to negotiate and execute a contract with Halff Associates to perform consulting services for Phase I of the Property Master Plan in an amount not to exceed \$387,698.00."
