Lot 3 - IT equipment, approximately 45 computer monitors (mostly Dell 24"), 10 sound bars, and 5 docks. Age unknown, working condition unknown.



Lot 4 - IT equipment, approximately 12 TV's. Mostly Vizio, sizes range from 42" to 72". Age unknown, working condition unknown.

Lot 5 - IT equipment, approximately 45 monitors (Mostly Dell 24") and 10 docks. Age unknown, working condition unknown.

Lot 6 - IT equipment, approximately 125 keyboards, 30 laptop bags, 20 iPad cases for 10.2" iPad, 30 power adapters, 15 sound bars (Dell). Age unknown, working condition unknown.

Lot 7 - IT equipment, approximately 30 monitors (Dell 24" and 17"), 12 keyboards, 10 docks and 30 laptop power adapters. Age unknown, working condition unknown.

Lot 8 - Model LM-5 Pressure Seal System, 120v, SN KAS3974. Good working condition when removed from service.

Lot 17 - Qty 1 Office cubical panel set, normal wear. Consists of 9 sections 36" tall x 15" wide x 2" thick.

Lot 18 - Qty 4 metal file cabinets, 2- drawer, normal wear. White cabinets measure 27-3/4" tall x 15" wide x 23" deep. Black cabinet 27-1/2" tall x 15" wide x 20" deep, no keys to any locks.
