Items No Longer Needed or Repairs Not Cost Efficient:

Qty 1- 2011 Ford F-150 Super Cab 4x2 SS, VIN 1FTFX1CF3BFA15569, Mileage 159,584.

Qty 1- 2010 Ford Super Duty F250 Extended Cab 5.4L V8, VIN 1FTSX2A53AEA95653, Mileage 70,788.

Lot 1- Qty (3) Binoculars: Qty 2- Pentax XCP; Qty 1- Bushnell

Lot 2- Qty (1) Garmin Etrex hand-held GPS. Comes on but screen not clear.

Lot 3- Qty (1) AFX Full enclosed XL helmet, normal wear.



Lot 4- Qty (3) Residential Closet Shutter Doors, door sections measure 78-1/4" tall and 24" wide when opened. Some hardware included, no tracks.

Lot 17- Qty (1) Cummins Power Generator, SN E120341256, Model GGHE-1205166, 60.0 KW, Natural Gas. Unit was replaced due to needing a bigger unit. Unit is in great shape and running great when pulled from service 7/17/2019. Has 160.9 engine hours.

Lot 18- Qty (1) Holt Cat Generator, SN 5NA11550, Model SR 5, 455.0 KW. Motor Model 3412 Cat; SN 8124080. Unit is in poor condition; no enclosure around generator, no fuel tank, it is sitting on a skid, and the control module is out.



Lot 19- Qty (9) Used black leather office chairs; various styles, all are rolling chairs, adjustable, very dirty (dusty), lots of scratches, poor condition; removed from service July 2022.
