Lot 17- Isco 4700 Refrigerated Autosampler, SN 207D01175; 15 years old, no longer working.



Lot 18- Approximately five tons of miscellaneous rusted scrap metal; Age unknown.

Lot 19- Approximately 10 tons of rusted scrap aluminum and sheet metal; assortment includes scrap pipe, channel, square tubing, flat iron, cable, assorted metal gutters, approximately six tons of rebar, and miscellaneous other metals; Age unknown.

Lot 20- Qty (5) Stainless steel elevator doors; measures 7' tall x 19" wide; Age unknown, rusted and weathered.
