By law this questionnaire must be filed with the records administrator of the local governmental entity not later than the 7th business day after the date the vendor becomes aware of facts that require the statement to be filed. See Section 176.006(a-1), Local Government Code.

A vendor commits an offense if the vendor knowingly violates Section 176.006, Local Government Code. An offense under this section is a misdemeanor.

Carollo has been selected for City of Houston, Staff Augmentation for Consent Decree for Wastewater CIP Project. Mbroh is a proposed team member, but a subcontract with Mbroh has not been executed.
