

Economic Overview

The Federal Open Market Committee (FOMC) maintained the Fed Funds target range 2.25% - 2.50% (Effective Fed Funds are trading +/-2.40%). Market probabilities strongly project decreases later this summer or early fall. Gradual FRB portfolio reduction continues by limiting reinvestment of maturing holdings, but that strategy will end this summer. May Non Farm Payroll only generated 75,000 new jobs, lowering the three month rolling average to 151k. Crude oil bounced up and down this spring around +/-\$60. The Stock Markets reached new highs, but retreated slightly. Overall economic activity, including housing, remains mostly mixed. The Three Month to Ten Year yield curve is fully inverted with a slight sway-back at Three Years.




