



WATERFOWL HUNTING SITE PERMIT

TERMS AND CONDITIONS OF THE PERMIT

All hunting of waterfowl on Lake Limestone, Lake Granbury, and Lake Possum Kingdom ("BRA Lakes") shall be conducted in full compliance with the following terms and conditions:

1. The hunting of waterfowl on BRA Lakes shall be conducted in accordance with all applicable provisions and requirements of the State and Federal hunting regulations, including, but not limited to, those cited in Chapter 64 of the Texas Parks and Wildlife Code and in Title 50, Part 20 of the Code of Federal Regulations, including all future amendments thereto.
2. Permittee shall comply with the Brazos River Authority's ("BRA") Regulations of Brazos River Authority Lakes and Associated Lands, as such may be updated or revised from time to time.
3. All hunting of waterfowl on BRA Lakes must be permitted by the BRA.
4. Permittee shall only hunt from the assigned BRA hunting site located at the GPS coordinates (and/or the numbered site if applicable) set forth in this Permit, and shall conduct all hunting within a radius of 20 feet of such coordinates (and/or numbered site) for Lake Limestone and Lake Granbury, and within a radius of 200 feet of such coordinates for Lake Possum Kingdom.
5. No more than four (4) hunters shall be allowed at any given permitted waterfowl hunting site at one time.
6. No trash, garbage, debris, sewage or other types of waste, including shell casings, shall be discharged, dropped or dumped into the lake.
7. Any facility or blind of any type that is placed in or on BRA Lakes at the hunting site which is permitted hereunder must be removed from the lake within ten (10) days following the close of the hunting season for which this permit has been issued. Any facility or blind that is not satisfactorily removed by the stated date will be seized, and the Permittee will not be eligible to receive a waterfowl hunting site permit during the next hunting season.
8. The permit for a waterfowl hunting site may be revoked by the BRA for violation of any applicable law or regulation, including the terms and conditions of this permit. In the event of revocation, the full permit fee shall be retained by the BRA.
9. PERMITEE SHALL INDEMNIFY AND HOLD HARMLESS THE BRA, ITS DIRECTORS, OFFICERS, AGENTS AND EMPLOYEES FROM ANY CLAIM, LOSS, LIABILITY, DAMAGE, INJURY AND/OR EXPENSE, INCLUDING REASONABLE ATTORNEY'S FEES, WHICH ARISE OUT OF, ARE CAUSED BY, OR ARE IN ANY WAY ATTRIBUTABLE TO THE ACTIVITIES DESCRIBED IN THIS PERMIT, WHETHER OR NOT DUE, IN WHOLE OR IN PART, TO THE BRA'S NEGLIGENCE.
