The Brazos River Authority (BRA) informed you by letter of the declaration of the Stage 2 – Drought Warning dated August 16, 2023, for the 25,000 acre-feet (AF) of water (Lower Colorado River Authority (LCRA) water) that BRA has contracted with the LCRA to be delivered from the Colorado River Basin for use in Williamson County.

You are receiving this letter because you have a water supply contract with the BRA for a portion of the LCRA water, and recent improvements to drought conditions in the Colorado River Basin have resulted in the combined storage of Lakes Buchanan and Travis rising above the Stage 2 – Drought Warning storage trigger of 900,000 AF. **Therefore, the BRA is downgrading the drought declaration to a Stage 1 – Drought Watch Condition for customers using LCRA water.**

As stated in the BRA Drought Contingency Plan (Plan), BRA will comply with LCRA drought declarations for this water. Under Stage 1, LCRA is requesting a ten percent (10%) reduction in water use that would have occurred in the absence of any drought contingency measures.

**We ask that you take action consistent with Stage 1 of the BRA Plan to achieve a ten percent (10%) reduction in your water use sourced from LCRA water.**
