The Brazos River Authority (BRA) informed you by letter of the implementation of the Stage 4 – Pro-Rata Curtailment at Lake Proctor dated August 16, 2023, and on February 5, 2024, another letter was sent informing you of the continuation of Stage 4 and included updated water use reductions for the year. Since then, Lake Proctor's lake level has risen about two feet above the Stage 1 trigger level of 1,158.2 feet above mean sea level. Although we've seen significant improvement, projections of the lake level indicate that it may decline back to the Stage 1 trigger level within the next 60 days. The BRA Drought Contingency Plan (Plan) allows for a drought stage to remain in place if there's a possibility that the reasons for initiation could return within 60 days.

Therefore, the BRA is downgrading Lake Proctor to a Stage 1 Drought Watch Condition. The stated goals in Stage 1 – Drought Watch of the BRA Plan are to raise awareness and to achieve a voluntary five percent (5%) reduction of the water use that would have occurred in the absence of any drought contingency measures. Additionally, any water use restrictions associated with the Stage 4 – Pro-Rata Curtailment are no longer in effect.

We ask that you take action consistent with Stage 1 of the BRA Plan to achieve a five percent (5%) reduction in water use.
