



Managing Water Rights in Texas

TCEQ manages surface water rights in Texas through Authorizations and Permitting, as well as Enforcement



Watermaster Programs

- Watermasters ensure compliance by monitoring stream flows, reservoir levels, water use, and coordinating diversions.
- Current Watermaster Programs in Texas:
 - Rio Grande Watermaster
 - South Texas Watermaster
 - Concho River Watermaster
 - *Newly Established - Brazos Watermaster*

Watermaster Programs

- Funded with annual fees paid by the water right holders within the program jurisdiction.
 - Annual fees/budget must be reviewed by WAC and approved by the Commission.
- Hands-on monitoring of surface water rights
- Ability to enforce priority system of surface water rights resulting in protection of domestic and livestock rights and senior water rights.
- Ability to quickly respond to complaints and inquiries.
- Ability to facilitate negotiations between concerned parties to ensure equitable distribution of water (Run of the River systems).

Outside of Watermaster Areas

- Surface Water Managed by TCEQ Regional Offices
 - Active water management
 - Addressing diversions outside of a watermaster area
 - Issuing temporary water rights permits
 - Responding to priority calls
 - Training staff

Establishing the New Program

Petition by Water Right Holders

- On January 10, 2013, the Executive Director received a petition from 37 water right holders on the Brazos River asking for the appointment of a Watermaster.
- On February 13, 2013, the Commission referred the petition to the State Office of Administrative Hearings for a complete administrative hearing and recommendation to the Commissioners for consideration.
- SOAH hearing was completed in late 2013.


Establishing the Brazos Watermaster


- ❖ On April 21, 2014, TCEQ Commissioners issued an order requiring a watermaster for the portion of the Brazos River Basin below and including Lake Possum Kingdom.
- ❖ Full implementation on June 1, 2015.

Texas Watermaster Areas

Current Status of New Program

- ❖ Stakeholder Meetings Held in Fall to Provide Information and Answer Questions
- ❖ Received Nominations for WAC members
- ❖ Hired Brazos Watermaster Staff:
 - Watermaster
 - Administrative Assistant
 - Watermaster Specialists (5)
- ❖ Appointed 15 members to the WAC.

Next Steps

- ❖ **April 2, 2015** – Initial WAC meeting in Waco.
- ❖ **April and May 2015** – Staff meeting water right holders, verifying meters, and training.
- ❖ **By June 2015** – Texas Watermaster Accounting System (TxWAS) Development to incorporate the Brazos Watermaster program.
 - This process will include entering all water rights into the system once development is complete.

Budget Timeline

- ❖ **March through May 2015** – Develop Fiscal Year 2016 budget.
- ❖ **June 1, 2015** – Brazos Watermaster program begins.
- ❖ **June through July 2015** – Hold WAC meeting and finalize the budget.
- ❖ **September 2015** – Present FY 2016 budget to Commission.
- ❖ **October/November 2015** – Generate and mail bills to Brazos water right holders.

Watermaster Information and Requirements

Applicable Regulations

- ❖ *Statute:* Texas Water Code, Chapter 11
- ❖ *Rules:* 30 TAC Chapter 304

Duties of the Brazos Watermaster

- ❖ Allocate water in accordance with the adjudicated water rights.
- ❖ Monitor stream flow, reservoir levels, and water use within the basin daily.
- ❖ Enforce compliance with water rights and respond to complaints.
- ❖ Determine whether a diversion would remove water that rightfully belongs to another user.
- ❖ When streamflows diminish, allocate available water among the water right holders according to users' priority date.
- ❖ Establish a watermaster advisory committee.

Requirements for Diverters

- ❖ Measuring Devices
- ❖ Notifications – Declarations of Intent (DOI)
- ❖ Reporting Requirements
- ❖ Costs
 - ❖ Annual Assessment
 - ❖ Meters

Compliance with the Rules

- ❖ Enforcement authority
 - ❖ Notices of Violation
 - ❖ Notices of Enforcement
 - ❖ Field Citations

Watermaster Advisory Committee

- ❖ Nine to 15 members
 - ❖ Water right holders or representatives of water right holders
- ❖ Meet at least once a year to discuss annual budget.
 - ❖ First Meeting April 2, 2015
 - ❖ Budget Meeting July 2015 (tentative)
